This contract provides for the the improvement of approximately 0.28 miles of County Road No. 5600 and 0.08 miles of County Road No. 5570 with grading, draining and surfacing and for the installation of signs and pavement marking at two intersections on County Road No. 9000, all in accordance with the Contract Plans and Provisions and the Standard Specifications. The Engineer's Estimate is \$395,000 to \$490,000.
