**Chapter 1.08 COMMISSIONER DISTRICTS AND VOTING PRECINCTS\***

**1.08.010 Commissioners' district boundaries designated.**

The boundaries of the county commissioner districts are established as indicated in this section. The legal descriptions of the voting precincts are as established in Section 1.08.020. Effective January 1, 2022, the districts shall be comprised of the following area:

A. Whitman County Commissioner District No. 1 is comprised of the following:

Township 20 N., Ranges 39 through 46 E. W. M.: inclusive.

Township 19 N., Ranges 39 and 41 through 46 E. W. M.: inclusive.

Township 19 N., Range 40 E. W. M.: all except the SE quarter of Section 33.

Township 18 N., Range 39 E. W. M.: Sections 2 through 11 inclusive together with the W half of Section 12.

Township 18 N., Range 40 E. W. M.: Sections 1 through 3, 10 through 15, 22 through 27 and 34 through 36 inclusive.

Township 18 N., Ranges 41 through 46 E. W. M.: inclusive.

Township 17 N., Range 40 E. W. M.: Sections 1, 2, 11 inclusive together with the N half of Section 12.

Township 17 N., Range 41 E. W. M.: Sections 5 and 6 inclusive; Section 4 except the SW quarter of said Section 4 and the NE quarter of Section 12 except the NW quarter of the NE quarter of said Section 12.

Township 17 N., Range 42 E. W. M.: Sections 1 through 6 and 9 through 15 inclusive; the NW quarter of Section 7; that part of SE quarter of Section 8 lying north and east of the Palouse River except NE quarter of said SE quarter; those parts of Sections 16, 17, and 21 lying north and east of the Palouse River; the NW quarter of the NW quarter of Section 22 together with the E half of the NW quarter except that part lying south and east of the Palouse River; the E half of said Section 22 lying north of the Palouse River; those parts of Sections 23 and 26 lying north of the Palouse River together with the N half of Section 24 and that part of SW quarter of said Section 24 lying north and west of the Palouse River.

Township 17 N., Range 43 E. W. M.: Sections 1 through 7 and 10 through 12 inclusive; the W half of the SW quarter of Section 8; the N half of Section 9; the NE quarter of Section 13; the W half of Section 18 along with the N half of the NE quarter of said Section 18 and the NW quarter of Section 19.

Township 17 N., Range 44 E. W. M.: Sections 1 through 13, 24, 25 and 36 inclusive; Section 14 except the SW quarter of said Section 14; that part of W half of Section 15 lying east of the Palouse River together with the N half of the NE quarter of said Section 15 except the S half of the S half of the NW quarter of said NE quarter; that part of the W half of Section 17 lying north of Dry Creek Road, County Road No. 2500; the SE quarter of Section 18, the N half of the SW quarter except the E half of the NE quarter of said SW quarter of said Section 18; the NW quarter of said Section 18 except the SE quarter of the SE quarter of said NW

quarter; that part of NE quarter of Section 19 lying east of Crumbaker Road, County Road No. 2460; the N half of Section 20 except that part lying west of Crumbaker Road, County Road No 2460; the N half of the NE quarter of Section 23.

Township 17 N., Ranges 45 and 46 E. W. M.: inclusive.

Township 16 N., Ranges 45 E. W. M.: Sections 1 through 5, Sections 8 through 17, Sections 20 through 29, and Sections 32 through 36 inclusive; the E halves of Sections 7 and 18; the SE quarter of the NE quarter of Section 19 together with the S half of said Section 19 and the S half of Section 31.

Township 16 N., Range 46 E. W. M.: inclusive.

Township 15 N., Range 45 E. W. M.: Sections 1 through 24 and 28 inclusive; that part of Section 29 lying inside the incorporated limits of the City of Pullman and lying east of State Route 27 (Pullman Street N. Grand Ave.) right-of-way centerline together with that part lying outside said incorporated limits of the City of Pullman except the NW quarter of said Section 29; that part of Section 32 described as follows:

Beginning at the NE corner of said Section 32, thence westerly along the N boundary of said Section 32 to a point where said boundary intersects with State Route 27 (N Grand Ave.) right-of-way centerline, thence southerly along State Route 27 (N Grand Ave.) right-of-way centerline to a point where it intersects with NW Larry Street right-of-way centerline, thence westerly along said NW Larry Street right-of-way centerline to a point where it intersects with NW Yates Street right-of-way centerline, thence southwesterly along said NW Yates Street right-of-way centerline to a point where it intersects with NW Deane Street right-of-way centerline, thence southeasterly along said NW Deane Street right-of-way centerline to a point where it intersects with NW Anthony Street right-of-way centerline, thence southwesterly along said NW Anthony Street right-of-way centerline to a point where it intersects with NW Hall Drive right-of-way centerline, thence southeasterly along said NW Hall Drive right-of-way centerline to a point where it intersects with NW Stadium Way right-of-way centerline, thence continuing southeasterly along said NW Stadium Way right-of-way centerline to a point where it intersects with State Route 27 (N Grand Ave.) right-of-way centerline and transitions to NE Stadium Way right-of-way centerline, thence continuing southeasterly along said NE Stadium Way right-of-way centerline to a point where it intersects with the E boundary of said Section 32, thence northerly along the said E Boundary to the NE corner of said Section 32 and the point of beginning;

Section 33 except that part SW of NE Stadium Way right-of-way centerline of said

Section 33 and that part of Section 34 lying inside the incorporated limits of the City of Pullman lying north and west of Airport Road and Terre View Drive right-of-way centerlines of said Section 34.

Township 15 N., Range 46 E. W. M.: Sections 5 through 8 and 17 through 20 inclusive.

Township 14 N., Range 45 E. W. M.: that part of Section 5 described as follows: Beginning at the intersection of NE Stadium Way right-of-way centerline and SE Nevada Street right-of-way centerline, thence southerly along said SE Nevada Street right-of-way centerline to a point where it intersects with Olympia Ave. right-of-way centerline, thence easterly along said Olympia Ave. right-of-way centerline to a point where it intersects with the E boundary of said Section 5, thence northerly along said E Boundary to a point where it intersects with NE Stadium Way right-of-

way centerline, thence southwesterly along said NE Stadium Way right-of-way centerline to the point of beginning;  
that part of Section 4 described as follows:

Beginning at the NE corner of said Section 4, thence westerly along the N boundary of said Section 4 to a point where said boundary intersects with NE Stadium Way right-of-way centerline, thence southerly along said NE Stadium Way right-of-way centerline to a point where it intersects with the W boundary of said Section 4, thence southerly along said W boundary of said Section 4 to a point where it intersects with Olympia Ave. right-of-way centerline, thence easterly and northerly along said Olympia Ave. right-of-way centerline to a point where it intersects with Grimes Way right-of-way centerline, thence easterly along said Grimes Way right-of-way centerline to a point where it intersects with Terre View Drive right-of-way centerline, thence northeasterly along said Terre View Drive right-of-way centerline to a point where it intersects with the E boundary of said Section 4, thence northerly along said E Boundary to the NE corner of said Section 4 and the point of beginning;

that part of Section 3 lying north and west of Terre View Drive right-of-way centerline.

B. Whitman County Commissioner District No. 2 is comprised of the following:

Township 15 N., Range 43 E. W. M.: the SW quarter of Section 35 and the S half of Section 36.

Township 15 N., Range 44 E. W. M.: the S halves of Sections 31 and 32.

Township 15 N., Range 45 E. W. M.: Sections 25 through 27, 35 and 36 inclusive;  
that part of Section 32 described as follows:

Beginning at the intersection of State Route 27 (N Grand Ave.) right-of-way centerline and NE Stadium Way right-of-way centerline, thence southeasterly along said NE Stadium Way right-of-way centerline to a point where it intersects with the E boundary of said Section 32, thence southerly along the said E Boundary to the SE corner of said Section 32, thence westerly along the S boundary of said Section 32 to a point where said boundary intersects with State Route 27 (N Grand Ave.) right-of-way centerline, thence northeasterly along said State Route 27 (N Grand Ave.) right-of-way centerline to a point where it intersects with NW Ritchie Street right-of-way centerline, thence northerly along said NW Ritchie Street right-of-way centerline to a point of intersection with NW Stadium Way right-of-way centerline, thence northerly and easterly along said NW Stadium Way right-of-way centerline to a point where it intersects with State Route 27 (N Grand Ave.) right-of-way centerline and the true point of beginning;

That part of Section 33 lying south and west of NE Stadium Way right-of-way centerline and Section 34 except that part lying inside the incorporated limits of the City of Pullman lying north and west of Airport Road and Terre View Drive right-of-way centerlines.

Township 15 N., Range 46 E. W. M.: Sections 29 through 32 inclusive.

Township 14 N., Range 42 E. W. M.: Section 12 inclusive; the E half of Section 1 and all of Section 13 in Whitman County.

Township 14 N., Range 43 E. W. M.: Sections 1, 2, 7, 10 through 17, 20 through 28, 35 and 36 inclusive; the SE quarter of Section 3; the W half and the NE quarter of Section 6 together with the NE quarter of the SE quarter of said Section 6; the SW

quarter of Section 9; and all of Sections 18, 19, 29, 30 and 32 through 34 in Whitman County.

Township 14 N., Range 44 E. W. M.: Sections 3 through 36 inclusive and those parts of Sections 1 and 2 lying west of State Route 195.

Township 14 N., Range 45 E. W. M.: Sections 1, 2 and 8 through 36 inclusive; Section 3 except that part lying north and west of Terre View Drive right-of-way centerline; Section 4 except that part described as follows:

Beginning at the NE corner of said Section 4, thence westerly along the N boundary of said Section 4 to a point where said boundary intersects with NE Stadium Way right-of-way centerline, thence southerly along said NE Stadium Way right-of-way centerline to a point where it intersects with the W boundary of said Section 4, thence southerly along said W boundary of said Section 4 to a point where it intersects with Olympia Ave. right-of-way centerline, thence easterly and northerly along said Olympia Ave. right-of-way centerline to a point where it intersects with Grimes Way right-of-way centerline, thence easterly along said Grimes Way right-of-way centerline to a point where it intersects with Terre View Drive right-of-way centerline, thence northeasterly along said Terre View Drive right-of-way centerline to a point where it intersects with the E boundary of said Section 4, thence northerly along said E Boundary to the NE corner of said Section 4 and the point of beginning;

Section 5 except that part of said Section 5 lying north and west of State Route 27 (N Grand Ave.) right-of-way centerline and that part of Section 5 described as follows:

Beginning at the intersection of NE Stadium Way right-of-way centerline and SE Nevada Street right-of-way centerline, thence southerly along said SE Nevada Street right-of-way centerline to a point where it intersects with Olympia Ave. right-of-way centerline, thence easterly along said Olympia Ave. right-of-way centerline to a point where it intersects with the E boundary of said Section 5, thence northerly along said E Boundary to a point where it intersects with NE Stadium Way right-of-way centerline, thence southwesterly along said NE Stadium Way right-of-way centerline to the point of beginning;

that part of Section 6 lying east of State Route 27 (N & S Grand Ave.) right-of-way centerline and that part of said Section 6 lying south of SW Crestview Street right-of-way centerline and Section 7 except that part lying north of SW Crestview Street right-of-way centerline.

Township 14 N., Range 46 E. W. M.: inclusive.

Township 13 N., Ranges 43 and 44 E. W. M.: all lying in Whitman County.

Township 13 N., Ranges 45 and 46 E. W. M.: inclusive.

Township 12 N., Range 44 E. W. M.: all lying in Whitman County.

Township 12 N., Ranges 45 and 46 E. W. M.: inclusive.

Township 11 N., Ranges 44, 45 and 46 E. W. M.: all lying in Whitman County.

C. Whitman County Commissioner District No. 3 is comprised of the following:

Township 19 N., Range 40 E. W. M.: the SW quarter of Section 33.

Township 18 N., Range 39 E. W. M.: Sections 1 and 13 through 36 inclusive along with the E half of Section 12.

Township 18 N., Range 40 E. W. M.: Sections 4 through 9, 16 through 21 and 28 through 33 inclusive.

Township 17 N., Range 39 E. W. M.: inclusive.

Township 17 N., Range 40 E. W. M.: Sections 3 through 10 and 13 through 36 inclusive along with the S half of Section 12.

Township 17 N., Range 41 E. W. M.: Sections 1 through 3, 7 through 11 and 13 through 36 inclusive; the SW quarter of Section 4; the W half and SE quarter of Section 12 together with the NW quarter of the NE quarter of said Section 12.

Township 17 N., Range 42 E. W. M.: Sections 18 through 20, 25 and 27 through 36 inclusive; Section 7 except the NW quarter of said Section 7; that part of the SE quarter of Section 8 lying south and west of the Palouse River and the NE quarter of said SE quarter together with the NE quarter and the W half of said Section 8; those parts of Sections 16, 17, and 21 lying south and west of the Palouse River; the SW quarter together with the SW quarter of NW quarter of Section 22, also those parts of E half of NW quarter and E half of said Section 22 lying south of the Palouse River; those parts of Sections 23 and 26 lying south of the Palouse River; the SE quarter of Section 24 together with that part of SW quarter of said Section 24 lying south and east of the Palouse River.

Township 17 N., Range 43 E. W. M.: Sections 14 through 17 and 20 through 36 inclusive; Section 8 except the W half of the SW quarter of said Section 8; the S half of Section 9; the W half together with the SE quarter of Section 13; the SE quarter together with the S half of the NE quarter of Section 18; the E half of Section 19 together with the SW quarter of said Section 19.

Township 17 N., Range 44 E. W. M.: Sections 16, 21, 22, 26 through 35 inclusive; the SW quarter of Section 14; the S half of NE quarter of Section 15 together with the S half of S half of NW quarter of said NE quarter, the SE quarter of Section 15 and the W half of Section 15 except that part of W half of said Section 15 lying east of the Palouse River; the E half of Section 17 together with that part of the W half of Section 17 lying south of Dry Creek Road, County Road No. 2500; the NE quarter together with the SE quarter of the NW quarter of Section 18 along with the E half of NE quarter of SW quarter and the S half of the SW quarter of said Section 18; Section 19 except that part of NE quarter of Section 19 lying east of Crumbaker Road, County Road No. 2460; the S half of Section 20 and that part of the N half of said Section 20 lying west of Crumbaker Road, County Road No. 2460; Section 23 except the N half of the NE quarter of said Section 23.

Township 16 N., Range 38 E. W. M.: all lying in Whitman County.

Township 16 N., Ranges 39 through 44 E. W. M.: inclusive.

Township 16 N., Range 45 E. W. M.: Sections 6 and 30 inclusive; the W halves of Sections 7 and 18; the N half of Section 19 except the SE quarter of the NE quarter of said Section 19; the N half of Section 31.

Township 15 N., Ranges 37 and 38 E. W. M.: all lying in Whitman County.

Township 15 N., Ranges 39 through 42 E. W. M.: inclusive.

Township 15 N., Range 43 E. W. M.: Sections 1 through 34 inclusive; Section 35 except the SE quarter of said Section 35; the N half of Section 36.

Township 15 N., Range 44 E. W. M.: Sections 1 through 25 and Sections 33 through 36 inclusive; the N halves of Sections 31 and 32.

Township 15 N., Range 45 E. W. M.: Sections 30 and 31 inclusive; that part of Section 29 lying inside the incorporated limits of the City of Pullman lying west of State Route 27 (Pullman Street N. Grand Ave.) right-of-way centerline together with that part lying outside said incorporated limits of the City of Pullman in the NW quarter of said Section 29; that part of Section 32 described as follows:

Beginning at the NW corner of said Section 32, thence easterly along the N boundary of said Section 32 to a point where said boundary intersects with State Route 27 (N Grand Ave.) right-of-way centerline, thence southerly along State Route 27 (N Grand Ave.) right-of-way centerline to a point where it intersects with NW Larry Street right-of-way centerline, thence westerly along said NW Larry Street right-of-way centerline to a point where it intersects with NW Yates Street right-of-way centerline, thence southwesterly along said NW Yates Street right-of-way centerline to a point where it intersects with NW Deane Street right-of-way centerline, thence southeasterly along said NW Deane Street right-of-way centerline to a point where it intersects with NW Anthony Street right-of-way centerline, thence southwesterly along said NW Anthony Street right-of-way centerline to a point where it intersects with NW Hall Drive right-of-way centerline, thence southeasterly along said NW Hall Drive right-of-way centerline to a point where it intersects with NW Stadium Way right-of-way centerline, thence southwesterly along said NW Stadium Way right-of-way centerline to a point where it intersects with NW Ritchie Street right-of-way centerline, thence southerly along said NW Ritchie Street right-of-way centerline to a point of intersection with State Route 27 (N Grand Ave.) right-of-way centerline, thence southwesterly along State Route 27 (N Grand Ave.) right-of-way centerline to a point where it intersects with the S boundary of said Section 32; thence westerly along the said S Boundary to the SW corner of said Section 32; thence northerly along the W Boundary of said Section 32 to the NW corner of said Section 32 and the point of beginning;

Township 14 N., Ranges 36, 37, 40 and 41 E. W. M.: all lying in Whitman County.

Township 14 N., Ranges 38 and 39 E. W. M.: inclusive.

Township 14 N., Range 42 E. W. M.: Sections 2 through 11 and 15 through 18 inclusive; all of Sections 14, 19 through 23 and 30 in Whitman County; the W half of Section 1.

Township 14 N., Range 43 E. W. M.: Sections 4, 5 and 8 inclusive; Section 3 except the SE quarter of said Section 3; the SE quarter of Section 6 except the NE quarter of said SE quarter; Section 9 except the SW quarter of said Section 9.

Township 14 N., Range 44 E. W. M.: those parts of Sections 1 and 2 lying east of State Route 195.

Township 14 N., Range 45 E. W. M.: that part of Section 5 lying north and west of State Route 27 (N Grand Ave.) right-of-way centerline; Section 6 except those parts of said Section 6 lying east of State Route 27 (N & S Grand Ave.) right-of-way centerline and lying south of SW Crestview Street right-of-way centerline; all of Section 7 lying north of SW Crestview Street right-of-way centerline.

Township 13 N., Ranges 37 through 40 E. W. M.: all lying in Whitman County.

Township 12 N., Ranges 37 and 38 E. W. M.: all lying in Whitman County.
