This contract provides for the improvements of Pine City-Malden Road, County Road No. 3000, Lancaster Road, County Road No. 4100 and Wawawai Road, County Road No. 9000 by removing guardrail, installing guardrail, traffic control and other work, all in accordance with the Contract Plans and Provisions and the Standard Specifications.

The Engineer's Estimate is \$768,500 to \$939,000.
